## National Database Descriptions

### National Database

A powerful, virtually instant multi-jurisdictional search of hundreds of millions state and county criminal records. This database is compiled from counties, Department of Corrections (DOC), Administration of the Court (AOC), and state sex offender registries from across the country. Also included in each search are national and international terrorism sources such as OFAC. This is an effective tool for discovering additional jurisdictions where criminal offenses may have occurred outside of an applicant's indicated residential and employment address history. This search includes the National Sex & Violent Offender Database, and the National Security Database. Please see the jurisdiction notes below for specific coverage and limitations for each included jurisdiction.

### National Sex & Violent Offender Database

Criminal records databases compiled from violent and sex offender registries from all fifty states and the District of Columbia. Photos, or links to photos, of the offenders are provided where available. Further research and verification is strongly recommended. Please see the jurisdiction notes below for specific coverage and limitations for each jurisdiction.

### Single State Database Search

A powerful, virtually instant search of criminal records databases compiled from various reporting agencies throughout a single state. Sources may include Department of Corrections, Administration of the Court, county courts, sex offender registries, and other proprietary records databases. This search includes the National Sex & Violent Offender Database. Please see the jurisdiction notes below for specific coverage and limitations for each jurisdiction.

### Instant Colorado Courts

A flexible, stand-alone search of criminal records, live from the Colorado Courts criminal records system. Research option includes wildcard and name only search options for listing a broader set of possible hits and two-step workflow allows review and population of positive hits to final report. Other states coming.

Contains access to the official state of Colorado criminal records repository, of over 8 million court cases involving more than 14 million parties. Information is contained on state district and county court system data records (with the exception of misdemeanor records in Denver County.) These records are NOT from a database, and criminal, civil, traffic and domestic cases are included in this data. Record retrieval is limited to 250 per search. **This jurisdiction is not included in any "InstaNational" Searches.**

### National Security Database

A database compiled from lists provided by U.S. and various international governmental agencies of individuals who may be involved in terrorist activities, money laundering, illegal imports, fraud against government agencies, violations of federal banking regulations, and fugitives from justice. Information may include date of birth, place of birth, citizenship, employment or group membership or affiliation. Please see the jurisdiction notes below for specific coverage, limitations, and sources.

# NATIONAL CRIMINAL DATABASE

## National Database Search Scope

### Matching Criteria

When Sex Offender Registry is included, sex offender records are searched using a fuzzy match on the first three letters of the first name and a fuzzy match on the last name. Name matching records with matching full DOB, matching partial DOB, or no DOB are returned. If Match Missing Dates is checked, the full first name is used with a fuzzy match.

When Sex Offender Registry is excluded, sex offender records are searched using a fuzzy match on the first three letters of the first name and a fuzzy match on the last name. Only name matching records with matching full DOB or matching partial DOB are returned. If Match Missing Dates is checked, the full first name is used with a fuzzy match.

National Security records are searched using a fuzzy match on the first three letters of the first name and a fuzzy match on the last name. Name matching records with matching full DOB, matching partial DOB, or no DOB are returned. If Match Missing Dates is checked, the full first name is used with a fuzzy match.

When Match Missing Dates is included, criminal records are searched using a fuzzy match on the first three letters of the first name and a fuzzy match on the last name. Name matching records with matching full DOB, matching partial DOB, or no DOB are returned. If Match Missing Dates is checked, the full first name is used with a fuzzy match.

When Match Missing Dates is excluded, criminal records are searched using the first name and a fuzzy match on the last name. Only name matching records with matching full DOB or matching partial DOB are returned. If Match Missing Dates is checked, the full first name is used with a fuzzy match.

A fuzzy last name match will ignore spaces, apostrophes, and hyphens in determining a match (e.g. Omalley, O Malley, O'Malley, and O-Malley are equivalent inputs and would all match).

Note- As indicated in the jurisdiction notes below; some jurisdictions have fewer than 50% of records with DOB information which may influence your decision to use the "Match Missing Dates" option. Broadening search scope with the "Match Missing Dates" option may produce large hit lists of false-positives. Limiting search scope may omit positive hits. Record retrieval is limited to 1,000 per search.
